7.2 Fining Committee

- Fining committee is now called Appeal Board, Don Henry said it is in place with 3 members from the North and 3 from the South
- BVA board will set fines at next board meeting, they can be up to \$1,000.00 per violation
- Dawn sends out violation letter, they have 30 days to correct, if not second letter sent given 15 days to correct, if not then a final notice is sent by registered mail with fine, then it goes to the lawyer.
- If they appeal, Dawn contacts Appeal Board gets a decision, if they agree with fine, then Dawn contacts lawyer
- Owner cannot say they didn't receive, final notice is sent by registered mail which is proof.
- Appeal Board is the only Board that can give an extension for the owner to pay, if they require more time.

8.1 New Lawyer

- BVA has a new lawyer, Web Melton of Bush Ross Attorneys at Law, Tampa
- Web Melton is waiting to get file from Pilka to see what he has be working on

8.2 Budget 2020

- budget was reviewed revenue \$287,640 and operating expenses \$287,640

8.3 Garbage rates

- Pasco County raised garbage rates in 2019, park rate will stay the same as All Haul is honouring its contract until 2021.
- last summer a number of properties were cut off of garbage pick-up for lack of payment some came in and paid in full, others set up payment plans, \$55,000 was collected in 5 months
- if neighbor allows garbage from anyone cut off and All Haul notices, (they have even opened bags) it will not be picked up and they will be notified that it is not allowed
 - if garbage is piling up CALL CODE, Dawn sends photo's to code
 The BVA is a Business and has to be run as a Business
